The estimated amount for the works is **NPR 26,43,762.92 (Including Vat and PS)**.

4. Pre-bid meeting shall be held at **[Hupsekot rural Municipality Office at 2:00 PM]** at **28th Dec. 2020**.
5. Electronic bids must be submitted to the office **[Hupsekot Rural Municipal]** through PPMO website www.bolpatra.gov.np/egp on or before **12:00 Noon** on **13th Jan, 2021**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM** on **13th Jan, 2021** at the office of **Hupsekot Rural Municipality**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NPR 80,000** which shall be valid for 30 days beyond the validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
